ADVISORY

In view of the prevailing circumstances and keeping in mind the larger concerned of health, environmental sustainability, energy conservation, financial prudence and smooth functioning of the University, following **ADVISORY** is being issued for compliance by all Schools, Departments, Centers, Hostels, Administrative Units and concerned stakeholders until further orders:

- 1. Edible Oil Consumption:** The University Guest House, Canteens, Hostels and Messes are advised to ensure optimum and judicious use of edible oil without compromising the quality and nutritional value of food. Dishes involving comparatively lesser consumption of edible oil shall be preferred in order to promote healthy dietary practices and to minimize the tendency of obesity, diabetes and related health concerns among students and staff. The detail health advisory in this regard shall be issued separately by the University Health Centre.
- 2. Promotion of Public and Sustainable Transport:** Preference may be given to the use of public transport, electric vehicles and shared conveyance/vehicle pooling by all stakeholders of the University in order to reduce fuel consumption, traffic congestion and environmental impact.
- 3. Online Participation of Experts and Examiners:** Invited Experts, Resource Persons, Ph.D., Viva-Voce Examinations and other academic interactions/examinations, wherever feasible may preferably be conducted in online mode. Experts and examiners may ordinarily be requested to join through online mode only.
- 4. Restriction on Financial Support for Private Vehicle and Foreign Travel:** The University shall not sponsor or provide financial support for travel by private-owned vehicle or for foreign travel for participation in Seminars, Workshops, Conferences or similar academic events.
- 5. Organisation of Major Events:** For the time being, the organisation of major events involving large participation from outside Institutions should be avoided. The number of external participants in University events may be kept to the minimum essential level.

All concerned are requested to ensure strict compliance with the above advisory in the larger interest of the University community.
