 - Two anti-ragging affidavits whose format is enclosed ;
 - If any candidate is serving in a government organization then he/she has to produce a **study leave certificate / NOC** at the time of admission otherwise his/her candidature will not be considered for admission.
- In a full-time PhD programme, you are not allowed to join any part/full-time job during the duration of the programme and also you are not permitted to take any other degree course; otherwise your Ph.D. Registration will be cancelled without any notice to you.
- Registration for Ph.D. programme would be automatically cancelled under the following conditions:
 - Two consecutive six-monthly progress reports are not submitted and all are not satisfactory;
 - Attendance is less than 75% in any term;
 - Not attending the Department for the first fifteen days after registration in the programme
- You can deposit the fee either in cash or through Demand Draft in favour of "**Finance Officer, Babasaheb Bhimrao Ambedkar University, Vidya Vihar, Raebareli Road, Lucknow**" in Canara Bank, B.B.A. University Branch on or before **15.07.2022** and the admission has to be completed by 20.07. 2022.
